Descripción general de la ayuda, Candidatos y Propuestas	
<p>CaixaImpulse is a programme for promoting the creation of services, products or businesses in the area of Life, Medical and Health Sciences. The CaixaImpulse Programme aims to drive the transformation of scientific knowledge into services, products or businesses that create value in society, reducing existing barriers and facilitating access to markets, contacts and key knowledge. Requirements:</p> <p><u>-For the Projects:</u> -Projects must be aimed at the valorization and commercialisation of the protected or protectable Assets resulting from research.-Projects must be related to the areas of Life, Medical and Health Sciences, specifically from the following fields: Life Sciences: Biomathematics, Cell biology, Human biology, Biochemistry and Molecular biology, Human physiology, Genetics, Immunology, Microbiology and Neurosciences. Medical and Health Sciences: Clinical sciences, Epidemiology, Forensic medicine, Occupational medicine, Internal medicine, Nutritional sciences, Pathology, Pharmacodynamics, Pharmacology, Preventive medicine, Psychiatry, Public health, Surgery and Toxicology. -Projects may or may not have a patent or utility model pending. If this is not the case, the protection of the asset must be included in the valorisation plan and budget, and the patent or utility model must be requested prior to signing the valorization agreement. <u>-For the Beneficiary of a Valorization Grant:</u> -They must be non-profit legal entities registered in Spain or Portugal. -Type of entity: Universities, university foundations, research and transfer centres, technology centres, hospitals, hospital foundations and non-profit institutions whose main activity is research. -They must be the owner or co-owner of the protected or protectable Assets resulting from the research and subject of the Valorization Plan. -One same Beneficiary may complete more than one application provided that they are associated to different protected or protectable Assets resulting from different research projects. -Established companies are explicitly excluded. <u>-For the Project Leaders:</u> -Project leaders must be legal person with tertiary qualifications (university graduate, professor or doctor). -Their exclusive or main dedication to the validation Project, according to the Promoters criteria, for the business idea or transfer to market is required. Project Leader may not be involved in more than one application. -The Project Leaders may or may not be the leader of the research project that generated the Assets. -He or she must be connected to the Beneficiary either by statute or employment.</p> <p>The implementation of the approved Valorisation Plans can be carried out up to 12 months after the Programme has concluded.</p>	
Financiación y Duración	
Grant: 23 projects . The amount of the grant to be requested is up to 70,000€ (52.500 € grant should be requested when the application is submitted and an extra grant up to 17.500€ can be requested and approved after reviewing the Valorisation Plan during the first half of the Programme).	
Procedimiento para la solicitud	
Applications must be presented in English by completing the online application form available on www.CaixaImpulse.com . The following documentation must be presented: a. Patent or utility model application b. Valorisation Plan c. Project leader's CV d. Transfer Team Representative's CV e. Other Project team members' CVs f. The most significant related documents and studies g. Letters of support or recommendation h. Prototypes i. 5 most important scientific publications j. Certification of data validation k. Certificate from the Spanish Tax Agency vouching that the applicant centre has fulfilled its obligations with regard to taxation. l. Social Security certificate, in force on the date of presentation of the Project. m. Copy of the power of attorney certifying the capacity of the representative to act on behalf of the Beneficiary. n. Acceptance Letter duly signed o. In case of projects in Consortium, the requested Grant to "la Caixa" Foundation distributed to the members of the Consortium.
